The Nassau County Village Officials Association (NCVOA), of which Plandome Heights is a member, is proud to announce the offer of an 8% discount on the supply cost of natural gas to residents and businesses of the 64 villages of Nassau County. Village residents and businesses may take advantage of an agreement with East Coast Power and Gas, an independent retail energy supplier.

The program is simple. When you enroll with East Coast Power and Gas your natural gas supply will be priced at an 8% discount as compared to National Grid's monthly posted price. National Grid will continue to read your meter, maintain the gas lines and provide emergency service for any leaks. National Grid will continue to bill you for the delivery of the gas to your property as they have in the past.

The only thing that changes is the gas supply charge will be replaced by East Coast Power and Gas's charge (which is 8% lower than if you had purchased your gas from National Grid). You will continue to receive one invoice with both the National Grid delivery charge and the East Coast gas supply charge. You make one payment to National Grid and they will forward to East Coast their portion.

To Summarize:

- You receive an 8% discount on your gas supply.
- No Sign-up or Cancellation fees, and no long-term commitment.
- National Grid continues to deliver and bill for delivery as in the past.
